The Weybourne Atmospheric Station have a new instrument for measuring atmospheric carbon dioxide, methane, nitrous oxide and carbon monoxide which has been added to the Atmospheric Station Technical Specifications document following the Atmospheric Monitoring Station Assembly recently. This is the Ecotech Spectronus Fourier Transform Infrared Spectrometer (FTIR) and testing has been paramount in getting this approved. This is a big step for Weybourne, many congratulation on getting it approved.

The UK ocean network have officially joined forces with Norway Institutions to co-host the Ocean Thematic Centre. This is great news as jointly we can provide broader leadership and expertise, in particular towards stakeholder involvement, new technologies, ship liaison and network design for a robust and optimally structured network

Sue Hartman from the National Oceanography Centre is now the Deputy Chair for the Ocean Monitoring Station Assembly. Congratulations Sue.

BEISS have agreed to fund DECC for the entry of a new atmospheric station to ICOS in January 2020. Simon O'Doherty (DECC) and Richard Sanders (NOC) recently attended the 8th General Assembly meeting in Paris to present the proposed new station.

UK funding under the NERC Core Programme (CLASS) is secured until 2024.
